## Item #4. Treasurer's Report (raised by Miriam Brace)

Last year at the AGM we had a motion to share the findings of the Auditor. However, after reaching out to the QLD Office of Fair Trading the club didn't have to count the loaned money as product sales and therefore, we only needed an Accountant to review the books.

The committee met and discussed the findings and had Align Accounting review and certify the accounts.

This year the accounts have already been reviewed and certified by Align Accounting.

There is a detailed breakdown of the accounts in the Annual report.

Just to recap - we are a not-for-profit organization, and there are five main sources of income for the club:

- Firstly, the club hires courts from Noosa Tennis Academy and Visitors and non-Tennis Club members contribute to the club when they pay the \$10 at the tennis club, or Club members when using the pay to play app spond at other venues.
  - 2nd of income is the Tournament that is hosted each year.
  - 3rd source is the membership fee (Senior \$18.00, Ordinary \$22.90)
  - 4th source is grants.
- 5th source donations to the club, or the club hosting events for third parties, where we supply pickleball setup, and training, etc.

As you can all see in the Annual Report - the Noosa Doubles Classic was basically breakeven and made a few dollars. The gift went down well, and going forward the PAA have updated their sanction policy so that gifts are no longer required.

Moving to the Profit / loss statements you can see that:

Play at the tennis club by non -Tennis club members is a major revenue raiser. There was a question about the Noosaville State school hall being available for free, however the School Hall is not "free". There is a \$80.00 payment per hire session. The hire of both the school hall and the tennis club are grouped together.

If anybody is interested, we paid \$960.00 + \$800.00 a total of \$1760.00 for the hire of the hall In Term 2, revenue in was \$1725.00. This was a trial period over three nights. Lessons learned - Tuesday night not very popular, Thursday night only overflow from the NLC so often only 4-6 players. You will see in next year's annual report that volunteer work at the School allowed the club to collect: **\$1196.25,** after stripe fees in term 3.

Another question was asked about the PAQ \$150.00 for court setup and convening at the Queensland Championships. As the club volunteers set up many courts for private functions the club has this as a service that we offer. PAQ requested an invoice. The invoice was for court setup and convening, and it was paid. Therefore, it's part of the Products Sold amount.

#### As the outgoing Treasurer I would also like to say:

During the 4 years, the club started with a few \$100 donations from some of the founding members and visitors to the region. During the next 4 years, there have been many hours of volunteer work at events to raise funds, from the first BBQ, to working on the Tri, to hosting corporate events for companies to try pickleball, and the many grants that Woody wrote and the tournaments that raised money for equipment, advertising and so much more.

After 4years of volunteer service to the club as treasurer, I'm proud, to report that the club's accounts are electronic and held in Quickbooks. The apps you are all using, either spond or Pickleplanner going forward enable accountability via reporting both from the app and the payment gateways (either stripe or square) and direct deposits into the accounts and into Quickbooks.

While some players would like cash, it's time consuming to manage and not viable in 2023.
